



Waiver of Liability, Release, Assumption of Risk & Indemnifying Agreement (including COVID-19)

1. For and in consideration of participant's registration with the Arcadia Ice Arena (hereafter AIA) and being allowed to participate in AIA events and member team activities, the parent(s) or legal guardian(s) of participants relinquish any and all liability and cause of action for personal injury, property damage or wrongful death occurring to participant arising from the participation in AIA events and member team activities or the sport of ice hockey/broomball, or any activities accidental thereto, wherever or however they occur and for such period said activities may continue, and by this agreement any such claims, rights, and causes of action that participant may have are hereby relinquished and the participant (or parent(s)/guardian(s)) does (do) so on behalf of my/our and participant's heirs, executors, administrators and assigns.
2. Participant and/or participant's parent(s)/guardian(s) acknowledge, understand and assume all risks inherent in ice hockey/broomball and any member team activities, and understand that said sport and activities involve risks to participant's person including bodily injury, partial or total disability, paralysis, and death, and damages which may arise there from and that I/we have full knowledge of said risks. These risks and dangers may be caused by the negligence of the participant or the negligence of other, including the "releases" identified below. It is further acknowledged that there may be risks and dangers not known to us or are not reasonably foreseeable at this time.
3. I understand that, among such risks, are the foreseeable and unforeseeable risks related to the current severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), also known as novel coronavirus or COVID-19. I understand that COVID-19 has been declared a worldwide pandemic by the World Health Organization. I further understand that there is not yet a scientific consensus as to the transmissibility, prevention, or treatment for COVID-19. I acknowledge the contagious nature of COVID-19, which may expose Participant to exposure or infection, and may lead to illness, injury, death, or other harm.
4. I, either on my own behalf as Participant or as Guardian/Parent of Participant, freely and voluntarily allow Participant to use Arcadia Ice's premises and facilities notwithstanding the risks related to COVID-19. I understand that this Waiver includes any claims based on COVID-19 infection or exposure, whether occurring before, during, or after use of Arcadia Ice's premises and facilities.
5. By signing below, I represent and warrant that Participant is not currently infected with COVID-19. I further agree that I will not allow Participant to enter upon or use Arcadia Ice's premises or facilities should Participant become ill with, or otherwise display symptoms of, COVID-19 unless/until cleared by Participant's healthcare provider. Participant is strongly encouraged to wear a mask or other face covering and to maintain social distancing to the extent reasonably practicable while using Arcadia Ice's premises and facilities. Although Arcadia Ice has developed a sanitation protocol for the premises and facilities, Participant is encouraged to bring hand sanitizer for personal use.
6. Arcadia Ice has developed a sanitation protocol for the premises and facilities, Participant is encouraged to bring hand sanitizer for personal use.
7. Participant and/or participant's parent(s)/guardian(s) acknowledge, understand and assume the risks, if any, arising from the conditions and use of ice hockey rinks and related premises and acknowledges and understands that included within the scope of this waiver and release is any cause of action, arising from the performance, or failure to perform maintenance, inspection, supervision or control of said areas and for the failure to warn of dangerous conditions existing at said rinks, for negligent selection of certain releases, or negligent supervision or instruction by release's.
8. It is the purpose of this agreement to exempt, waive and relieve release's from liability for personal injury, property damage, and wrongful death caused by negligence, including the negligence, if any, of release's.
9. "Release's" include Arcadia Ice Arena, Desert Palms Shopping Center, participants, coaches, officials, sponsors, advertisers, owners and operators of the premises used to conduct any event and each of them, their officers, directors, agents and employees.
10. Participant or participant's parent(s)/guardian(s) agree if any claim for participant's personal injury or wrongful death is commenced against release's, he/she shall defend, indemnify and save harmless release's from any and all claims or causes

of action by whomever or wherever made or presented for participant's personal injuries, property damage or wrongful death.

11. I hereby give my consent to Arcadia Ice L.L.C./Arcadia Ice Arena to use my image/likeness (or in the case of a child...my child's image/likeness) for the purpose of inclusion in any publication or advertising related to the Arcadia Ice Arena.

Participant and/or participant's parent(s)/guardian(s) acknowledge that they have been provided and have read the above paragraphs and have not relied upon any representations of release's, that they are fully advised of the potential dangers of ice hockey/broomball and the risk of COVID-19 and understand these waivers and releases are necessary to allow amateur ice rentals to exist in its present form.

I HAVE CAREFULLY READ THE TERMS OF THIS WAIVER AND FULLY UNDERSTAND ITS CONTENTS. I ACKNOWLEDGE AND AFFIRM THAT THIS WAIVER IS FREELY AND VOLUNTARILY GIVEN WITH THE UNDERSTANDING THAT THE RIGHT TO LEGAL RECOURSE AGAINST ARCADIA ICE, IF ANY, IS KNOWINGLY GIVEN UP IN EXCHANGE FOR THE USE OF ARCADIA ICE'S FACILITIES. I AM AWARE THAT BY SIGNING THIS WAIVER I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY AGENTS, ASSIGNEES, HEIRS, AND PERSONAL REPRESENTATIVES MAY HAVE AGAINST ARCADIA ICE.
